

USHA's Certified Referees

In our effort to upgrade the officiating in handball, the USHA now offers five levels of certification for referees.

Level One: Pass written certification exam or attend a referee's clinic conducted by a Level 5 referee.

Level Two: Pass written certification exam and attend a referee's clinic conducted by a Level 5 referee.

Level Three: Pass exam, attend clinic, and receive positive observation report by a qualified official (Level 4 or 5).

Level Four: Pass exam, attend clinic, and receive positive observation report by qualified Level 4 or 5 official while officiating Open play.

Level Five: This level of certification is reserved for Level 4 officials who are also qualified to conduct referees certification clinics.

With the bulging numbers of certified referees, thanks to a number of referees clinics over the summer, the decision has been made to list only the USHA Members in the magazine. We still have the non-members on file. So, if you don't see your name all you need do is send in your membership and asked to be reinstated.

Referees Badges

We're proud of you for taking the time to achieve your level of certification and want to acknowledge you at the tournaments. We'll have badges for all those who have gained certification. Badges cost \$1 each for new referees or replacements. Send \$1 to the USHA, 2333 N. Tucson Blvd., Tucson, AZ 85716.

We hope you'll wear your badge proudly.

The USHA is now compensating referees at the national four-wall championships for officiating matches from the quarterfinals through the finals in all events. Qualified referees receive up to \$20 per match. It is my hope that all state and regional tournaments will follow the USHA lead and add a surcharge to the entry fee in order to compensate qualified referees.

The names, cities of residence and level of all certified USHA referees appear below. These are the people you can count on to know the rules when they referee your match.

If you have attended a referee's certification clinic and your name doesn't appear on this list, please write me with the place and date of the clinic you attended. If you took the test and your name doesn't appear on the list, please write me as your test may have been one of those I received without identification.

Many of those listed under Level One would surely qualify for Level Three status if the test had been taken and sent to me. However, determining many of the Level Three and Four referees will take some time because of the necessary observation process. For those of you who have completed the test and attended a clinic, letters of recommendation from USHA Officials and/or certified referees in your area would be very beneficial in speeding up the process.

For those of you who haven't attended a clinic, there will be two given at each four-wall national tournament. Additional certification clinics will be held during the course of the year and will be announced in advance.
